APPLICATION FOR MEMBERSHIP IN THE OUTDOOR RECREATION COUNCIL (ORC) AND REQUEST FOR INFORMATION

Type of membership applied for, select one of the following:

Provincial Organization Member

Must be a not-for-profit society incorporated in British Columbia which is considered by the Board to be most closely identified with the interests of organized individual participants throughout British Columbia in the field of outdoor recreation represented by the society. To qualify as a Provincial Organization Member, the organization must also be an umbrella organization representing the interests of two or more affiliated outdoor recreation clubs in addition to itself. Each Provincial Organization Member is entitled to receive notice of, attend and to vote on all matters at general meetings of the Council.

Regional Organization Member

A federal or provincial non-profit society, recreation group, or local government organization in British Columbia having an interest in outdoor recreation which is not eligible to be a Provincial Organization Member. Each Regional Organization Member is entitled to receive notice of, attend and to vote at all general meetings of the Council on all matters except the election of directors and amendments to bylaws.

Individual Member

A person who subscribes to the Council's purposes of and who is interested in furthering those purposes. Each Individual Member is entitled to receive notice of, attend and to vote at all general meetings of the Council on all matters except the election of directors and amendments to bylaws.

Approval of application & membership dues

As per ORC's Bylaws, a person or an organization becomes a member after the Board of Directors has accepted the application, an invoice has been issued and dues have been paid. Membership dues: **\$192.00** for Provincial Organization Members, **\$96.00** for Regional Organization Members, and **\$50** for Individual Members.

Designated Representative

Each Organization Member is required to appoint an individual as its Designated Representative to represent it at ORC's general meetings and to act as a contact person for communication with ORC. Organization Members are responsible for ensuring that a replacement is named if that person is no longer associated with the Member Organization.

Voting privileges

Provincial Organization Members are entitled to vote on all matters at ORC's general meetings. Regional Organization Members and Individual Members are entitled to vote at all ORC's general meetings on all matters **except** the election of directors and amendments to bylaws.
